Election programme to the election of the Central council of Homoeopathy from the State of Himachal Pradesh.

Notice is hereby given that:

An election to the Central Council of Homoeopathy is to be held for electing one(1) member under clause (A) of sub-section(1) of section 3 of the Homoeopathy Central Council Act, 1973 from the state of Himachal Pradesh from amongst Homoeopathy Medical Practitioners entered in the State Register of Homoeopathy and renewed for the year, 2015 maintained by the State Council of Homoeopathy System of Medicine on 28.05.2015.

1. Any person who fulfills the requisite qualification under section 5 of the Central Council of Homoeopathy Act, 1973 is eligible to stand for this election.
2. Form of nomination paper may be obtained from the Returning Officer from his office on any working day between 11 a.m. to 3.p.m.
3. Nomination paper may be delivered by a candidate or his proposer in person or by post so as to reach the Returning Officer not later than 3 p.m. on or before 1st July, 2015.
4. Nomination paper will be taken up for scrutiny on 02.07.2015 at 11.a.m.
5. Notice of withdrawal of candidature may be delivered by a candidate or his proposer, duly authorized in writing by the candidate for the purpose to Returning Officer before 3.p.m. 03.07.2015.
6. The Voting Papers shall be dispatched to the electors from 22.07.2015.
7. Counting of votes shall be done on 24.08.2015 from 11 a.m. in the office of the Returning Officer and marked ballot papers received up to 22.08.2015 till 3.p.m. shall only be counted.
8. The result shall be declared immediately after the counting of votes is over on 24.08.2015.
